1. Approval of Minutes of March 16, 2019.

One change was made to the minutes:

- The location of the future social justice forum art show will be the Third Street Gallery instead of the Prichard Gallery.

Tallent moved to accept the minutes as amended, seconded by Kelly and the motion carried.

2. Review of Calendar.

The calendar was reviewed. There was one change:

- HRC at the Market will be held on August 22, rather than August 30.

3. Kenworthy Theatre Stage Lift.

The Kenworthy Theatre decided on a different portable stage lift which is better suited and \$10,000 less than the one originally selected. This lift will allow access to the Kenworthy stage as well as other stages and can be used for those who might have ambulatory issues or use a wheelchair. It is also easier and lighter to transport and will fit through the narrow doorways of the theatre. The possibility of installing a ramp was explored but uses too much space. This lift will be available for use at all community events such as Artwalk, Rendezvous in the Park, and events at the University of Idaho. It will serve all community members and will be stored at the Kenworthy. Faunce will check with City Administration to see if this sponsorship falls within Commission guidelines. Kelly moved to sponsor the portable stage lift for \$500 pending clarification with City Administration. This motion was seconded by Simmons and the motion carried.

4. Indigenous People's Day.

Possible Indigenous People's Day activities were discussed to include the Vandal Nation drum group and story tellers. It was also suggested Native American student groups be asked to be involved. The Latah Human Rights Task Force is considering a Living Voices presentation at the schools. Kelly moved to sponsor activities for Indigenous People's Day, seconded by Awwad-Rafferty, and the motion carried. Staff liaison will contact the Farmer's Market to borrow a canopy for the event in case of inclement weather.
