The meeting was called to order at 4:35 PM

MEMBERS PRESENT: Wendy McClure (virtual), Chair; Cynthia King (virtual), Laurabeth Landis, Jack Porter, Nels Reese, Steve Taylor, Ali Tong

1. Approval of minutes from February 27, 2020 (ACTION ITEM)

Porter moved for approval of the minutes as presented, seconded by Reese. Motion carried by acclamation.

2. Introduction of New Members

Introduce new members on the Commission and provide a brief overview of Commission projects.

Board members introduced themselves, as well as their reasons and background to joining the Historic Preservation Commission. Steve came to Moscow because of a job opportunity at the Appaloosa Horse Club and Laurabeth and Ali are here because of secondary education.

Reese presented on the formation, background and project history of the Historic Preservation Commission. He also included his summer work of walking the Fort Russell neighborhood and compiling lists of 20 especially notable homes. Reese recommends the book by Lillian Otness, "A Great Good Country: A Guide to Historic Moscow and Latah County, Idaho." Some discussion about reprinting the book followed.
