The meeting was called to order at 4:03 p.m.

REPORTS

1. Latah Human Rights Task Force Report

The task force is putting together the virtual MLK breakfast. Nominations for the Rosa Parks Award are open. The deadline is January 4. There will be no admission costs for the breakfast; however, donations will be accepted. The task force inquired about the City providing / hosting the Zoom portion of the breakfast. The request will be forwarded to City Supervisor Riedner. The task force has sent support to the Wassmuth Center for Human Rights in Boise after the Anne Frank memorial was defaced.

2. Strengthening Relationships with Police & Community

The mental health and crisis intervention virtual panel was successful with 70 in attendance. Both panels have been recorded. Chief Fry said there were good questions and information about history and what is happening now. It was a great educational opportunity and some involved in the mental health system learned new information about future community efforts.

3. Bias Reporting System

Faunce and Laflin met with Yolanda Bisbee and talked about UI's system. Bisbee is very supportive of a bias reporting system for the City; however, UI does not want to manage it. Bisbee might be willing to help and have a UI person on a City team. The City's system could be modeled after UI's. Once the City's system is up and running, it can be expanded to the county. Bisbee dispelled any concerns about occasional false reports as these types of reports are easy to weed out. Faunce and Laflin will have another meeting with City Attorney Bautista. Faunce will also be talking with Martinez and Agidius as well.

4. Voices of Moscow

Yuksel has located another videographer, Max Sallow, to produce a video showcasing the Voices of Moscow survey responses.

5. Future Social Justice Forum: Restorative Justice

There was discussion regarding what topics might be covered during a restorative justice social justice forum such as the criminal justice system, schools, and/or other programs. It was decided that restorative justice would best be presented from a basic approach such as what it is, why it is important, what are the implications, and how it is implemented. Suggestions for future forums included protest movements and how police are responding to them as well as relations with the gay community. A discussion on future forums will be included on the January agenda.

6. Food Insecurity / Poverty on the Palouse

Stevens was absent and unable to update this topic for the Commission. It was noted that there are currently many food drives in our community.
