1. Approval of February 4, 2021 Minutes (ACTION ITEM)

2. Moscow Affordable Housing Trust (ACTION ITEM)

Update on MAHT budget request to City Council.

Baukol reported that Nils Peterson, Executive Director of Moscow Affordable Housing Trust (MAHT) had set up a meeting with City of Moscow Administration and will pursue the budget request through City Council. FAHC will revisit how to be supportive of this effort after the request has been formally made.

3. Assessment of Fair Housing Survey Questions Discussion (ACTION ITEM)

Baukol spoke for Bonnar and Pitman, that they had been doing some research into accessibility for housing. Force mentioned the notes she provided last month to the Commission, but has not made any more progress since. Commissioners discussed the TBD survey date, and concluded there was no urgency to finalize questions at this time.

Commissioners discussed possible options for the upcoming tabling at the Moscow Farmer's Market. They decided that they would prefer a Saturday sometime in the month of July, and asked Staff to submit a request for July 17, 2021.
