The meeting was called to order at 7:16 PM

1. Approval of minutes from the June 19, 2018-Steve McGeehan

2. City Sustainability Report-Kelli Cooper

Kelli Cooper, City of Moscow Sustainability Technician, will update the Commission on the City's sustainability activities.

ACTION: Receive the report and provide applicable feedback to staff.

Cooper showed the commission a picture of the latest Wisescape® Demo garden at the entrance to the Water Reclamation and Reuse Facility. It is an example of a dry river bed. Cooper also informed the commission that work on the Community Greenhouse Gas Inventory is moving forward, with most data requests having been sent out. Cooper met with Avista this morning to discuss her request and plans to meet with UI staff in the near future. Cooper also updated the commission on the Farmer's Market recycling program. She has met with the Market Manager to discuss next steps with the goal being to complete some disposables audits and possibly a couple pilots this year. We will be working on implementing recycling and composting programs simultaneously. Cooper also informed the commission that the City Hall restroom upgrades to high efficiency fixtures is expected to take place within a couple weeks.

3. Moscow High School Subcommittee-Ilan Carter

Report on sustainability activities at Moscow High School including the environmental club and soil society.

ACTION: Receive the report and take other such action as deemed appropriate

Carter informed the commission that since it is summer, not much is happening right now. Carter mentioned the annual Turtle Conservation Trip where students travel to Mexico to assist researchers in getting the newly hatched turtles into the sea. He also mentioned that several students from the environmental club went to Phillips Farm for a work day. In addition, the Soil Society has members who are currently maintaining the garden in the courtyard of the high school every couple weeks. It is mostly planted with natives. Some student volunteers will also be doing face painting at Rendezvous in the Park.

McGeehan provided a brief recap of the visit from Dwight Curtis from the last meeting. The next steps to come out of that meeting are for the SEC to research, collect and summarize more information, including talking to Nichole Baker about the Wisescape project at City Hall. Scott Fedale provided some handouts of information on entities in the Pacific Northwest that are doing this successfully. Discussion on the need to establish baseline data followed and how best to collect that information. A subcommittee was formed to accomplish the needs discussed. Members of the SEC who will serve on the subcommittee are Debbie Kadlec, Tim Hatten, Scott Fedale, and Steve McGeehan. Mark Heinlein, from the Parks and Recreation Commission, will also serve on the subcommittee. Kyle Steele will follow up with Dwight Curtis to find out who will serve as a representative of Parks staff.
