1. Approval of March 3, 2022 Minutes (ACTION ITEM)

1. Wellness Fair

Baukol gave a brief report regarding tabling at the Wellness Fair.

2. ARPA Funds – Rental Relief Awards for Moscow – IHFA

Staff reported on the American Rescue Plan Act (ARPA) Idaho Housing and Finance Association (IHFA) rental assistance funds distributed to Moscow residences. IHFA reported distributing \$511,000 to one hundred forty-five (145) renters within the City. The total number was reported as of the end of February, 2022.

The Commission requested a report about Appaloosa Court, and Sivula outlined that the new owner was working to get a new well pump and connecting to the City sewer system. Sivula offered to take the Commissioners to the park for a tour and the Commission expressed interest in advocating for the residents of the park in any way they could, even though it is outside of city limits. Sivula will coordinate with the Appaloosa Court residents to organize a tour.
