REGULAR AGENDA

1. Discussion regarding the Potential University of Idaho Historic District (ACTION ITEM)

Staff was recently contacted by the Idaho Heritage Trust who indicated that they have been contacted by the University of Idaho regarding the preservation of the Niccolls Building on campus. The Commission has previously had discussions with the University regarding a Historic District Nomination and it may be time to revisit the topic. There have been recent meetings between the State Historic Preservation Office and the University of Idaho that the Commission will be updated on.

Reese is working with the University of Idaho's Office of the President and will provide more updates at the next Commission meeting.

2. Orchid Awards (ACTION ITEM)

The topic of Orchid Awards will be discussed, as well as strategies for finding appropriate candidates. The Commission talked about setting up a tour of the Unitarian Universalist Church of the Palouse, which is being considered for an Orchid Award. Various other locations were suggested as potential awardees, as well as an architect of notable contribution. The Orchid Award Committee will make the final decisions at the August meeting. The Commissioners were instructed to continue to scout out other possible buildings.

3. Homeowner Handout (ACTION ITEM)

Review the draft handout intended to inform homeowners of Moscow's history and historical resources.

The new homeowner's guide for the Fort Russell Historic District, that was created by King, will be voted on at the next meeting, and will also be included with the Fort Russell companion guide that Reese is working on.

4. Future Interpretive Signs Locations and Content (ACTION ITEM)

Discuss the possibilities for interpretive signage in Friendship Square, Fort Russell, or other locations.
The Commission continued discussing the photographs and layout of the Friendship Square sign, as well as where the final placement should be.

5. Farmers Market Tabling Recap (ACTION ITEM)

Discuss how the Historic Preservation Commission's table at Moscow Farmers Market went.
Norman reported that only four people stopped by the booth at the Farmers Market, as it was rainy. The Commissioners discussed potentially holding the tabling event again, and who volunteered to attend it last time. Several ideas for engaging community members at the Farmers Market were mentioned.

- The Idaho Heritage Trust's annual conference will be held in Pocatello, Idaho from September 19-22, 2022.
