1. Approval of Pathways Commission December 13, 2022 Minutes (ACTION ITEM) – Tanya Denison

Charles Matthews (Moscow) inquired about Paradise Ridge and would also like to know what jurisdiction MPC has. He would also like to know what construction is occurring near the south end of the University of Idaho arboretum.

COMMISSION SURVEY QUESTION HISTORY

From 2002-2014 the commission questions were integrated into the Citizen Survey. The 2016 survey consisted only of the citizen survey questions and starting 2017 commission questions were sent out separately in their own survey. The 2019 commission survey was never approved by City Council and published as the onset of Covid prioritized other projects and we never revisited the survey results. Starting with the 2017 Commission survey, questions were organized by commission whereas previous surveys were scrambled. The 2017 survey also included each commission's mission statement. The survey will be sent out at the beginning of October and questions are due back from Commissions by September
