2. Wellness Fair Discussion (ACTION ITEM)

The Latah County Wellness Fair was held on March 26th, 2024.

The Commission tabled at the Latah County Wellness Fair on March 26th. Commissioners discussed some of the conversations that were had there and noted that the increasing rent and declining affordability of manufactured home parks came up frequently. Some of the same speaking strategies that were used at the Wellness Fair can also be used at the Farmers Market tabling events.

3. Fair Housing Training Discussion (ACTION ITEM)

The Annual Fair Housing training is scheduled for April 18th from 8am-12pm at the 1912 Center. Commissioners will discuss the organization and last-minute details of the event.

The Commissioners talked about the possibility of recording the training and working with IFHC on providing continuing education credits. The survey questions from last year will be revised with additional prompts based on discussion from the Commissioners. It was decided to have both a paper survey and QR code for an online survey available on the day of the event.

The 2023 Commission Survey was distributed for review and discussion at a future meeting.

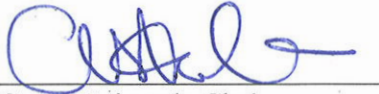
