3. Idaho Transportation Department Update – ITD Staff

Staff from the Idaho Transportation Department (ITD) will provide an update on various construction and planning projects.

4. Multi-Modal Transportation Plan Update (ACTION ITEM) – Cody Riddle

The Moscow Multi-Modal Transportation Plan, adopted in July of 2014, needs to be updated to remain current and competitive in various grant programs. Staff will guide an initial discussion focused on the Capital Improvement Plan included in the document.

Riddle introduced the Multi-Modal Transportation Plan and discussed some of the updates that are needed. There is no specific date to finalize the plan and forward approval to City Council, but it would be preferable to have it completed by spring 2025. The Commissioners requested a more in-depth presentation with maps describing each proposed project area. All the projects were rated and ranked during the original evaluation process.

Staff described what buffered bike lanes look like and their specific uses. There was a discussion about electric bikes and how that can be incorporated into the updated multi-modal plan. The Commission proposed that Moscow City Code regarding e-bikes should be updated. It was suggested that ADA pedestrian ramps should

be included in the updated Plan. The items that are listed as “with ITD approval” are not in Moscow’s jurisdiction but would be requested and encouraged for implementation to the Idaho Department of Transportation.

REPORTS

Sumner talked about the Farmers Market tabling event and the community feedback he received. The Commissioners discussed some of the higher priority items that the public brought up.
