1. City Parks Pesticide List

David Schott (Moscow Parks & Facilities Manager) has provided a list of pesticides and herbicides available for use by the city. The SEC typically reviews this list each year and makes recommendations if needed. David will also present a brief summary of the city's pesticide use policy, the plan to manage one pesticide-free park per calendar year, and an update on the City's Edible Forest - Harvest Park.

PROPOSED ACTIONS: Receive the report or take other action as appropriate.

Pesticide list is presented and reviewed by SEC each year.

Moscow was designated a Bee City USA affiliate in 2022 and since then the City has also initiated a pesticide free park each year.

Legally the City does need to manage "noxious" weeds.

The City started a Strategic Irrigation Program. Which means they water ½" every 2 weeks during irrigation season. This follows the natural lawn cycle: spring green, summer dormancy, fall green.

David gave an overview of Harvest Park.

PESTICIDE OVERVIEW

Parks Pesticide Application Program

- Parks has a philosophy of minimal pesticide applications.
- Pesticide list is reviewed by the SEC each year.
- All Parks staff have a State of Idaho Professional Applicators license and follow the pesticide label.
- 2019 Parks and Recreation Master Plan Update, Action Item 2 Goal: Reduce pesticide use in public parks and properties.
- Pesticide usage is a tool in the Integrated Pest Management (IPM) toolbox.

Parks Pesticide Application Program

- Have initiated a pesticide free park each year since 2022:
 - 2022 Anderson Frontier Park
 - 2023 Kiwanis Park
 - 2024 Triangle Park
 - 2025 Morgan's Orchard Park
- City of Moscow was designated as a Bee City USA affiliate in 2022.
 - Currently developing a formalized Integrated Pest Management Plan
 - Pollinator-Friendly Pest Management: Create and adopt an integrated pest management (IPM) plan designed to prevent pest problems, reduce pesticide use, and expand the use of non-chemical pest management methods.

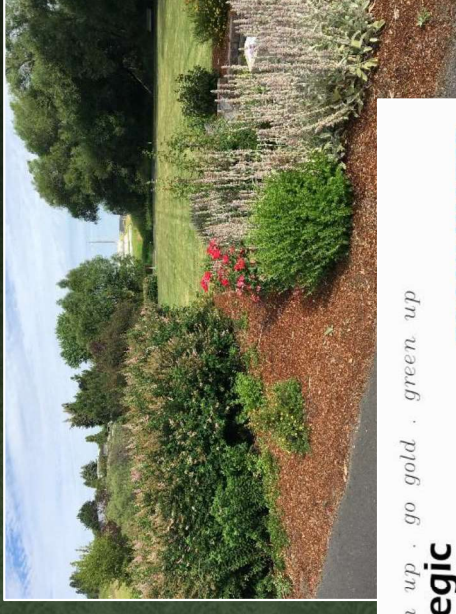


Regulations

- Weeds designated by the State of Idaho as “noxious” will be managed according to state law (Title 22 Agriculture and Horticulture Chapter 24 Noxious Weeds), as to be in accordance with state and federal laws.
- City Code 12-1 Definitions: Noxious Weed(s). Any plant having the potential to cause injury to public health, crops, livestock, land or other property, and which is designated as noxious by the Idaho Department of Agriculture or by Latah County pursuant to Idaho Code Title 22, Chapter 24. (Ord. 2010-20, 09/07/2010)

Integrated Pest Management

- Cultural: Only apply pesticides as needed.
 - Doughtown Trees(25), aphids last treated in 2017
- Heavy mulching in landscape planters, Berman Creekside Park.
- Healthy turf minimizes weeds but...
 - Does require water.
 - Hydrowise irrigation control
 - Drought tolerate turf (Simplot Inferno tall fescue)
 - Strategic Irrigation Program
- Cover Crop, Harvest Park
- Community tolerance.

and keeps cool-season grass healthy by allowing dormancy, the protective mechanism of the plant during extreme weather. Watering at a rate of 1/2" every 2 weeks prevents plant mortality and helps conserve our declining aquifer. A natural lawn cycle is spring green up, summer dormancy, fall green up. Please join your Parks Dept and turn down those thirsty turf sprinklers!

Summary

- Cultural: Only apply pesticides as needed.
- Measures to reduce pesticide usage.
 - Pesticide Free Park
 - One park per year
 - Selected by staff and communicated to PRC and SEC.
 - Rotates each year.
 - Includes a playground
 - Gives park visitors with pesticide sensitivities a park option
 - Excludes East City Park, Oylear Fields, and the Moscow School District Community Playfields.
 - Do not treat
 - Playgrounds
 - Berman Creekside Park Sensory and Butterfly Gardens
 - Harvest Park



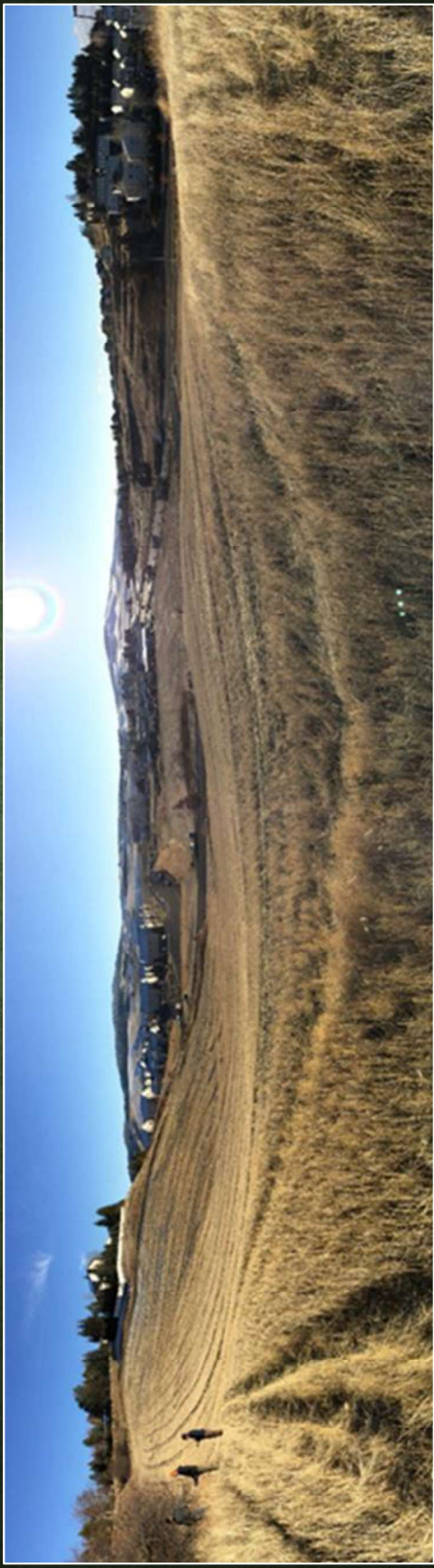
HARVEST PARK OVERVIEW

Introduction

- Harvest Park, located on Southview Avenue is a 4.09 acres site. The historic wheat field was acquired to be developed as an 'edible forest' with food-bearing trees, shrubs, and other flora.
- The City of Moscow initially received interest in the concept of an edible food forest through the Moscow Tree Commission.



Vision



- Harvest Park is a long term, dynamic landscape. This unique space is intended to provide educational opportunities and an example to our community of stewardship of a public food forest. This unique space will create a sense of place and community pride for the City of Moscow for generations to come.

Purpose

- The purpose of Harvest Park is to provide the community with a public food forest with a strong emphasis on public education and outreach about the benefits and pride in growing food.



Initial Goals

- Officially name the park.
- Conceptual planning.
- Develop a management plan for the Harvest Park.

Conceptual Planning

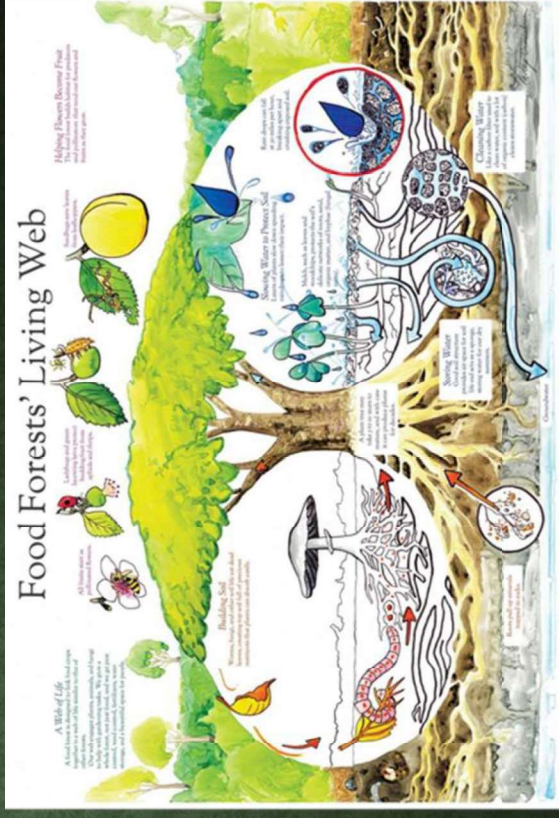
- **Moscow City Council approved the conceptual plan on September 3, 2019 after public workshops and recommendations from the Tree Commission and Parks and Recreation Commission.**



Harvest Park Management Plan Overview

- The Tree Commission and Parks and Recreation Commission reviewed and recommended approval to City Council in May of 2022.
- City Council approved the Harvest Parks Management Plan through Resolution 2022-18 in June of 2022.
