The Commission talked about low attendance at the training.

5. Housing Authority Discussion (ACTION ITEM)

The Commission will continue the discussion on the potential creation of a Housing Authority and review historical housing data from the City of Moscow.

Casey Bolt talked with the Commission about creating a new housing authority and spoke about his meetings with Mike and other parties regarding required next steps and regulations. He would like to make a direct request to Moscow City Council to approve a new housing authority. The Commissioners talked

about the various concerns that affordable housing developers have shared in regard to the current requirements and processes. Staff provided some of the census data for Moscow from 2023.
