2. Update on Fair Housing Training Event

Belknap reported the staff has contacted the Intermountain Fair Housing Council (IFHC) to begin the planning process for the spring fair housing training event. IFHC has requested that we coordinate our training date with the City of Lewiston to make their travel arrangements more convenient. Due to property managers' limited availability in May it was decided that the training event would be held in the fall this year. The training date has been set for Wednesday, September 18th at the 1912 Center Great Room. Staff will send out a save the date so that property managers are aware of the shift to the fall this year. Commission members concurred.
