1. Mission of the Human Rights Commission

It is the duty of the Commission to affirm, encourage, and initiate programs and services within the city designed to eliminate discrimination, improve human relations, and effectuate the spirit and intent of applicable human rights legislation. In these efforts, the Commission may enlist the support of community groups and public agencies.

PROPOSED ACTIONS: Select two questions to submit to the City of Moscow; or take such other action deemed appropriate.

6. The "Longest Table" Dinner Sponsorship (ACTION ITEM)

A vote will be taken to use funds, up to \$1250.00, of the remaining Fiscal budget.

PROPOSED ACTIONS: Vote to ask for approval to use funds, up to \$1250.00, for The "Longest Table" Dinner; or take such other action deemed appropriate.

7. Request a Fourth Location to Vote (ACTION ITEM)

Current locations: Hamilton Indoor Recreations Center, Latah County Fair Exhibit Building, and University of Idaho Student Recreation Center.

PROPOSED ACTIONS: A vote to send a letter to the Moscow City Council, requesting that they petition Latah County officials for a fourth voting location in Moscow to minimize long lines and waiting times; or take such other action deemed appropriate.
